

### Performance summary:

- 150,238 participants (excluding children accessing early connections) have had an approved plan since July 2013. 142,240 of these continue to be active.
- 73,664 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 5,337 participants have entered the Scheme and there are 3,222 children accessing early connections at the end of June 2022.
- 26,472 plans have been reviewed this guarter.
- 7,112 access decisions have been made in the quarter, of which 5,359 met access and are still active.
- 232 (4.4%) of the new active participants this quarter identified as Indigenous, taking the total number of Indigenous participants in VIC to 4,518 (3.2%).
- 603 (11.3%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) <sup>3</sup>, taking the total number of CALD participants in VIC to 16,751 (11.8%).



- Total annualised plan budgets at 30 June 2022 were \$9,227m and payments from 1 July 2021 were \$6,594m.
- The number of active providers at the end of June is 6,768, growing by 3% in the quarter.
- Utilisation was 72% from 1 October 2021 to 31 March 2022, with no service district in Victoria more than 10 percentage points from the adjusted national benchmark.
- •There were no service districts where the top 10 providers were providing more than 85% of payments.







<sup>&</sup>lt;sup>4</sup> Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).



- Bayside Peninsula has the highest number (17,328) of active participants, while Mallee has the lowest (2,402).
- The average annualised plan budget at the end of June for active participants is \$64,900 (\$53,000 for participants not in SIL and \$355,200 for participants in SIL).
- The average payment for the 12 months ending 30 June 2022 is \$49,400 (\$38,300 for participants not in SIL and \$314,200 for participants in SIL).
- Inner East Melbourne has the highest average annualised plan budgets and payments across all participants.
