What is the Outcomes Framework?



The Outcomes Framework is a list of questions about your life at different ages.



The Outcomes Framework is used to

measure progress towards NDIS goals



show how and where the NDIS is helping



• check changes over time



• find what supports help good outcomes



• compare results with other population groups.

Why measure outcomes?



There are 4 reasons why we need to measure outcomes.



We measure outcomes to

• support the NDIS Act 2013



• check if the NDIS works well



 follow plans and policies about including people with disability in the community




• check the progress of participants.

How was the Outcomes Framework developed?



1. Desktop review



We reviewed

• frameworks that already existed



• population surveys that already existed.



2. Consulted with experts




3. Pilot study



We interviewed 400 participants with family or carers.



The study told us that we needed a shorter question list.



The Outcomes Framework includes a

Short Form



• Long Form.



The Short Form has


• 4 versions for participants



3 versions for family or carers.




All participants should answer the Short Form.




The Long Form has more questions than the Short Form.



Not every participant will have to do the Long Form.



The Outcomes Framework follows a lifespan approach.



The lifespan approach means that we understand that changes may happen at any stage of life.



The lifespan approach helps guide the NDIS to support participants to reach their goals.

How to use the Outcomes Framework



The outcomes question list is asked when a participant first enters the NDIS.



The answers from the questions are then used to compare to answers given at a plan review.



The outcome question list is asked at each NDIS plan review.




The questions can be asked

over the phone.




The outcome question list can take up to 25 minutes to finish.

Outcomes Framework training



The success of the NDIS should be measured by the positive change for the participant.




Some outcomes may take longer to see change.

About the Goal Attainment Framework




The Goal Attainment Framework was made to help
