
The new Information and Communications Technology (ICT) system test commenced in Tasmania in the December 2022 quarter. The Quarterly Performance Dashboard combined data from the current and new ICT systems, where it is available. Data from the new ICT system is not available for all tables shown. Where this is materially incomplete at the Tasmanian Level, the underlying data for the corresponding Tasmanian dashboard has not been shown. However, at a National level the data is less impacted and continues to be included. This may lead to restatements of information in future reports.

Performance summary:

- 651,943 participants (excluding children accessing early connections) have had an approved plan since July 2013. 610,502 of these continue to be active.
- 391,141 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 21,530 participants have entered the Scheme and there are 17,589 children accessing early connections at the end of June 2023.
- 69,570 plans have had reassessments this quarter.
- 31,263 access decisions have been made in the quarter, of which 23,641 met access and are still active.
- 2,132 (9.9%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants nationally to 46,694 (7.6%).
- 1,845 (8.6%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) 4, taking the total number of CALD participants nationally to 55,751 (9.1%).

[•] The PSG metrics are based on the recommendations of the 2019 Tune Review. The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

¹ The PSG measures currently do not include participants who have migrated to the new Information and Communications Technology (ICT) system in Tasmania. However, the PSG measures are being remediated where there is a similar process and data available between the new and old systems. PSG result in the previous quarter may be restated due to ongoing logic refinement and changes in data quality.

- Total annualised plan budgets at 30 June 2023 were \$45,715m and payments from 1 July 2022 were \$34,724m.
- The number of active providers at the end of June is 19,969, growing by 2% in the quarter.
- Utilisation has been 76% from 1 October 2022 to 31 March 2023, with 6% (5 out of 80) of service districts more than 10 percentage points below the adjusted national benchmark.
- In 4% (3 out of 80) of service districts, the top 10 providers provide more than 70% of payments.



Service districts more than 10% below plan utilisation benchmark:

- NT East Arnhem: 52% vs 74% benchmark
- WA Kimberley-Pilbara: 59% vs 73% benchmark
- · WA Wheat Belt: 58% vs 72% benchmark
- NT Darwin Remote: 57% vs 69% benchmark
- SA Far North (SA): 64% vs 75% benchmark

Service districts above the market concentration benchmark:

- NT Katherine: 79% vs 70% benchmark
- NT Barkly: 76% vs 70% benchmark

¹ Active providers refer to those who have received payment for supports provided to Agency-managed participants and plan managers.

² The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in Supported Independent Living (SIL) in each service district and the length of time participants have been in the Scheme.

³ Total annualised plan budgets refer to those in the current plans of active participants at the end of quarter.

⁴ Total plan inflation consists of plan budget changes occurring at plan reassessment as well as changes occurring within a plan between reassessments.


⁵ Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).




■ Active participants by State/Territory as at 30 June 2023

- NSW has the highest number (182,920) of active participants.
- The average annualised plan budget at the end of June for active participants is \$74,900 (\$56,400 for participants not in SIL and \$414,900 for participants in SIL).
- The average payment for the 12 months ending 30 June 2023 is \$60,700 (\$42,700 for participants not in SIL and \$387,700 for participants in SIL).
- NT has the highest average annualised plan budgets and payments. This is partially driven by a higher proportion of participants in SIL compared to other States/Territories.

¹ There are 3 active participants as at 30 June 2023 with missing State/Territory information. These participants are not shown in the chart.

² Average annualised plan budgets are derived from total annualised plan budgets in the current plans of active participants at 30 June 2023. Average payments are calculated as the average of the annualised monthly payments in the same 12 month period, weighted by the participants that are active in each month.

³ Given the small size of the Other Territories (OT) and missing groups, average annualised plan budgets and average payments for these groups are not shown.
