Performance summary:

• 54,886 participants (excluding children accessing early connections) have had an approved plan since July 2013. 52,451 of these continue to be active.

• 33,664 active participants have not previously received disability support via State and Commonwealth government programs in the past.

• In the current quarter, 1,626 participants have entered the Scheme and there are 1,172 children accessing early connections at the end of June 2023.

• 6,422 plans have had reassessments this quarter.

• 2,618 access decisions have been made in the guarter, of which 1,978 met access and are still active.

• 170 (10.5%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in Western Australia to 4,185 (8.0%).

• 98 (6.0%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) ³, taking the total number of CALD participants in Western Australia to 4,202 (8.0%).





South Metro has the highest number (8,384) of active participants, while Goldfields-Esperance has the lowest (875).

- The average annualised plan budget at the end of June for active participants is \$79,200 (\$60,700 for participants not in SIL and \$404,400 for participants in SIL).
- The average payment for the 12 months ending 30 June 2023 is \$59,100 (\$42,500 for participants not in SIL and \$361,700 for participants in SIL).
- Central North Metro has the highest average annualised plan budgets and payments across all participants.
