## Financial benchmarking surveys

The NDIA commissions an independently managed and delivered annual benchmarking survey on the operational models of disability service providers.

The survey is designed to collect information on staffing numbers, costs and profits of support providers in the NDIS.

The NDIA uses the data and market analysis from the survey to:

- assist in the development of a sustainable NDIS market that supports participant choice
- inform our role as market steward and help us to make evidence-based decisions
- increase the information available to providers to gauge performance against their peers and support their transition to a more open and competitive market.

The survey is conducted externally and the NDIA receives anonymised information from the survey provider.

## Financial benchmarking survey 2022-23

In October 2022, the Minister for the NDIS, the Hon. Bill Shorten announced the NDIS Review.

The review will be finalised in October 2023 and is expected to look at the design, operations and sustainability of the NDIS, including matters related to pricing.

Due to the NDIS Review and the extensive financial benchmarking work conducted by the NDIA over the last six years, the NDIS is not running the 2022-2023 financial benchmarking survey.

Disability service providers can still access financial benchmarking services from independent survey providers.

The NDIA will continue to work closely with the sector in monitoring market conditions and cost structures.

## **Benchmarking survey results- 2021-22**

The 2021-22 financial benchmarking survey was managed by Deloitte Access Economics on behalf of the NDIA.

The survey was conducted from November 2021 to February 2022.
