Good afternoon everyone,

The NDIS is seeking expressions of interest from Occupational Therapists (OTs) interested in being involved in an Interim List to prescribe complex home modifications for NDIS participants residing in the ACT and the southern region of NSW who are unable to access necessary parts of their home. These modifications may require changes to the design of a home which may involve some structural alterations. Typical complex modifications include:

- changes to a bathroom/toilet creating accessible bathroom facilities, possibly including the removal of a wall to increase room size if required
- extensive changes to the kitchen to create fully accessible facilities
- significant alterations to access points such as large permanent ramps, creating a new accessible entrance
- installation of alternatives to stairs up to one flight
- installation of hoists where tracking is affixed to the ceiling or wall and requires structural reinforcement of the wall or ceiling, and
- wiring related to environmental control systems.

The expression of interest process will be used to identify OTs who can undertake a two day NDIS training program in February/March 2016 (dates to be confirmed in early January) at a cost of \$800 per OT. OT Australia has approved the course for continuing education credit points.

All OTs will continue to be able to prescribe simple home modifications such as the installation of basic ramps and rails without undertaking the NDIS training.

Expressions of Interest should include your name, the organisation you currently work for, details of your qualifications and experience in designing complex home modifications and a brief response to the requirements detailed in Part 2 of the attached.
