What is this fact sheet about?



Compensation is a payment you get because something happened to change how you live your life.



For example, you might have been hurt in a:

- car accident
- public place.



How much compensation you get depends on how much your injury changes your life.



We need to know about your compensation so your plan pays for the right supports and services.



If your compensation pays for supports and services that are in your plan, we might need to take some funding out of your plan.



The amount we take out is called a **Compensation Reduction Amount**.

When do we work out a Compensation Reduction Amount?



Your plan should only pay for supports you can't get anywhere else, such as from:

- compensation
- family and friends.



Your plan won't pay for supports and services your compensation:

- already pays for
- should pay for.



We only work out a Compensation Reduction Amount when compensation pays for supports and services that are in your plan.

How do we work out a Compensation Reduction Amount?



We might ask you to fill out a Compensation Information Form.



This form includes questions about:

- what happened to you
- your compensation.



We might need more information about your compensation.



This could include:

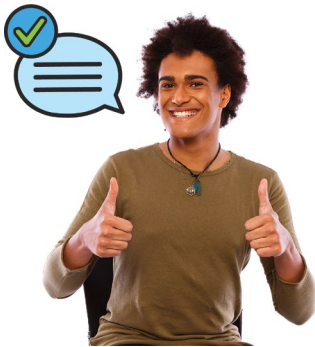
- court documents
- **settlement** documents.



A settlement is a type of compensation payment.



We will ask for your **consent** if we need to talk to anyone about your compensation.



When you give consent, you say it is ok for someone to do something.



We will only use this information to work out your Compensation Reduction Amount.



We will keep your information private.

How does a Compensation Reduction Amount change your plan?



Your plan won't change until we have all the information we need about your compensation



Usually we won't change your plan until your next plan review.



This means you can keep using the plan you have now in the same way.



We won't just change your plan for 1 year.



We will spread your Compensation Reduction Amount across your future plans.

Before we change your plan, we will tell you:



- what your Compensation Reduction Amount is



- how long it will be in your plan.

What if you aren't happy with the decision?



If you don't agree with our decision, you can ask us to review your plan.



You need to ask us within 3 months of hearing what our decision is.



If you still don't agree with our decision, you can ask the Administrative Reviews Tribunal (ART) to look at it.

What if something changes?



If you think that your life has changed a lot, you can ask us to review your plan.



We might ask you:

- for more information
- to prove how much your life has changed.



If we review your plan, we might change your:

- Recoverable Amount
- Compensation Reduction Amount.

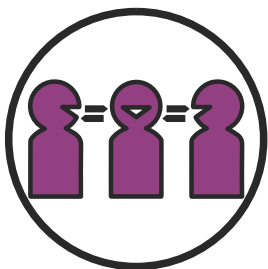
