# Transcript for Western Australia Quarterly Performance Dashboard as at 30 September 2020

This dashboard provides a quarterly comparison of key statistics relating to active participants and their experience in the Scheme. It also includes market characteristics, key outcomes and participant satisfaction results.

## Section 1 Participants and Planning

A table displays the following key statistics on the Western Australia participant pathway experience as at 30 September 2020 and 30 June 2020.

• The number of active participants, excluding Early Childhood Early Intervention, also known as E-C-E-I, increased from 32,335 as at 30 June 2020 to 34,751 as at 30 September 2020.

• The number of children in the E-C-E-I gateway receiving initial supports increased from 212 as at 30 June 2020 to 260 as at 30 September 2020.

• The number of children in the E-C-E-I gateway not receiving initial supports decreased from 116 as at 30 June 2020 to 38 as at 30 September 2020.

• Plans approved (including E-C-E-I with initial supports) versus Bilateral Estimates increased from 87% as at 30 June 2020 to 92% as at 30 September 2020. Includes participants with approved plans who have transferred from the Western Australia NDIS. Bilateral Estimates are as at 30 September 2020.

• The proportion of participants fully or partially self-managing their plan remained stable at 36%, from 30 June 2020 to 30 September 2020.

• The proportion of plans activated within 90 days remained stable at 87%, from 30 June 2020 to 30 September 2020. Trial participants are excluded. Participants with initial plans approved after the end of 2019-20 quarter 3 are excluded. They are relatively new and it is too early to examine their durations to activation.

• The number of participant plan reviews completed decreased from 6,644 in the quarter ending 30 June 2020 to 5,762 in the quarter ending 30 September 2020. Plans less than 30 days in duration have been excluded.

• The proportion of decisions made to undertake Participant Requested Reviews (PRRs) within 21 days remained stable at 100%, from the quarter ending 30 June 2020 to the quarter ending 30 September 2020.

• The proportion of Participant Requested Reviews (PRRs) completed after decision made within 42 days decreased from 66% in the quarter ending 30 June 2020 to 64% in the quarter ending 30 September 2020.

• The proportion of Reviews of Reviewable Decisions (RoRDs) completed after request is received within 90 days increased from 86% in the quarter ending 30 June 2020 to 99% in the quarter ending 30 September 2020.

• The number of access decisions in progress increased from 769 as at 30 June 2020 to 868 as at 30 September 2020.

• The proportion of access decisions that were made or further information requested within 21 days of access request decreased from 100.0% in the quarter ending 30 June 2020 to 99.9% in the quarter ending 30 September 2020.

• The proportion of access decisions that were made within 14 days of final information being provided remained stable at 99.8%, from 30 June 2020 to 30 September 2020.

• The proportion of first plan approved after access decision has been made that were for participants aged 0 to 6, within 70 days increased from 59% in the quarter ending 30 June 2020 to 95% in the quarter ending 30 September 2020.

• The proportion of first plan approved after access decision has been made that were for participants aged 7 or above, within 90 days increased from 49% in the quarter ending 30 June 2020 to 82% in the quarter ending 30 September 2020.

There were 32,335 active participants (excluding E-C-E-I) as at 30 June 2020. During 2020-21 quarter 1, there were 2,503 plan approvals and a negative net movement of 87 participants across jurisdictions and Scheme exits. This resulted in 34,751 active participants (excluding E-C-E-I) as at 30 September 2020. Additionally, there were 260 children in the E-C-E-I gateway receiving initial supports as at 30 September 2020. When including E-C-E-I, the total number of active participants (including E-C-E-I) as at 30 September 2020 was 35,011.

The following key statistics summarise the Western Australia performance as at 30 September 2020.

• 35,628 participants have entered the Scheme (including E-C-E-I) since July 2013. 35,011 of these continue to be active.

• 16,685 active participants are receiving supports for the first time.

• In the current quarter, 2,503 participants have entered the Scheme and there are 260 children with initial supports in the E-C-E-I gateway at the end of September 2020.

• 5,762 plans have been reviewed this quarter.

• 2,998 access decisions have been made in the quarter, 2,326 of which met access and are still active as at 30 September 2020.

• 270 (10.8%) of the new active participants this quarter identified as Indigenous, taking the total number of Indigenous participants in Western Australia to 2,372 (6.8%).

• 240 (9.6%) of the new active participants this quarter are Culturally and Linguistically Diverse, also known as CALD, taking the total number of CALD participants in Western Australia to 2,941 (8.5%).

### Section 2 Provider and Market Metrics

A table displays the following key statistics on Western Australia provider and market metrics as at 30 September 2020 and at 30 June 2020.

• The total number of active providers (with at least one claim ever) increased from 1,352 as at 30 June 2020 to 1,511 as at 30 September 2020. Active providers refer to those who have received payment for supporting Agency-managed participants.

• The total number of active providers in last quarter increased from 726 as at 30 June 2020 to 836 as at 30 September 2020. Active providers refer to those who have received payment for supporting Agency-managed participants.

• Utilisation (which is calculated as a 6 month rolling average with a 3 month lag) decreased from 63% as at 30 June 2020 to 62% as at 30 September 2020.

• Plan utilisation by service district. The proportion of service districts that are more than 10 percentage points below the benchmark remained stable at 17%, from 30 June 2020 to 30 September 2020. The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in supported independent living in each service district and the length of time participants had been in the Scheme.

• Market concentration. The proportion of service districts where more than 85% of payments for supports go to the top 10 providers decreased from 33% as at 30 June 2020 to 25% as at 30 September 2020.

• The proportion of payments paid within 5 days (portal) increased from 99.2% as at 30 June 2020 to 99.8% as at 30 September 2020.

• The growth in annualised plan budget decreased from 27.4% as at 30 June 2020 to 14.9% as at 30 September 2020. This measure is based on plans reviewed in the current quarter.

The following comments are made regarding the Western Australia provider and market metrics as at 30 September 2020.

• The number of active providers at the end of September is 1,511, growing by 12% in the quarter.

• Utilisation was 62% in the six months from 1 January 2020 to 30 June 2020, with 17% of service districts in Western Australia more than 10 percentage points below the adjusted national benchmark.

• In 25% of service districts, the top 10 providers provide more than 85% of supports by value.

A chart displays the Western Australia distribution of service districts by plan utilisation as at 30 September 2020. The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in supported independent living in each service district and the length of time participants had been in the Scheme.

2 out of 12 (17%) service districts are more than 10 percentage points below the adjusted national benchmark.

1 out of 12 (8%) service districts are between 5 and 10 percentage points below the adjusted national benchmark.

9 out of 12 (75%) service districts are within 5 percentage points of the adjusted national benchmark.

No service districts are between 5 and 10 percentage points above the adjusted national benchmark.

No service districts are more than 10 percentage points above the adjusted national benchmark.

Service districts below benchmark:

• Goldfields-Esperance: 44% versus 58% benchmark.

- Kimberley-Pilbara: 50% versus 61% benchmark.
- Wheat Belt: 52% versus 60% benchmark.
- North East Metro: 69% versus 72% benchmark.
- North Metro: 58% versus 60% benchmark.
- Midwest-Gascoyne: 51% versus 53% benchmark.

A chart displays the Western Australia distribution of service districts by market concentration as at 30 September 2020.

No service districts have more than 95% of payments going to the 10 largest providers.

2 out of 12 (17%) service districts have between 90% and 95% of payments going to the 10 largest providers.

1 out of 12 (8%) service districts have between 85% and 90% of payments going to the 10 largest providers.

3 out of 12 (25%) service districts have between 65% and 85% of payments going to the 10 largest providers.

2 out of 12 (17%) service districts have between 45% and 65% of payments going to the 10 largest providers.

4 out of 12 (33%) service districts have less than 45% of payments going to the 10 largest providers.

Service districts above benchmark:

- Great Southern: 94% versus 85% benchmark.
- Midwest-Gascoyne: 93% versus 85% benchmark.
- Goldfields-Esperance: 86% versus 85% benchmark.

#### Section 3 Service District Summaries

The following comments are made regarding the Western Australia experience at service district level as at 30 September 2020.

• North East Metro has the highest number of active participants (5,765), while Goldfields-Esperance has the lowest (546).

• Central North Metro has the highest average annualised committed supports.

• North East Metro has the highest utilisation at 69%, whilst Goldfields-Esperance has the lowest utilisation at 44%.

• Only utilisation of committed supports from 1 January 2020 to 1 June 2020 is shown, as experience in the most recent 3 months is still emerging.

## Section 4 Participant Outcomes and Satisfaction

A table displays the following key statistics on Western Australia participant outcomes and satisfaction.

For Participant and Scheme Outcome metrics from the Corporate Plan as at 30 September 2020. These Outcomes results only include participants who have been in the Scheme for at least two years. Trial participants are excluded. The measures compare the responses at the participants' most recent plan review, with the result at Scheme entry (which constitutes the Baseline). The following three indicators are outcomes measures.

• The percentage - Participant employment rate - ages 15 and over increased from 24% at Baseline to 25% at the latest review.

• The percentage - Participant social and community engagement rate - ages 15 and over increased from 37% at Baseline to 46% at the latest review.

• The percentage - Parent and carer employment rate - all ages increased from 46% at Baseline to 49% at the latest review.

The following results indicate the percentage of participants rating their overall experience as 'Very Good' or 'Good' by pathway stage in the current versus previous quarter. Participant satisfaction results for 2019-20 quarter 4 have been restated using data as at 30 September 2020 due to retrospective changes in the underlying data. These changes mainly arise from lags in data collection.

• The percentage for the 'Access' stage increased from 71% in the quarter ending 30 June 2020 to 79% in the quarter ending 30 September 2020.

• The percentage for the 'Pre-planning' stage increased from 76% in the quarter ending 30 June 2020 to 83% in the quarter ending 30 September 2020.

• The percentage for the 'Planning' stage decreased from 85% in the quarter ending 30 June 2020 to 81% in the quarter ending 30 September 2020.

• The percentage for the 'Plan review ' stage increased from 76% in the quarter ending 30 June 2020 to 90% in the quarter ending 30 September 2020.
