



Section 1: Introduction

The 30 June 2021 NDIS Quarterly Report to Disability Ministers included an analysis of 12-month average payments for the years ending 30 June 2017 to 30 June 2021 by Support Independent Living (SIL) status and age group. The analysis indicates a consistent increase in average payments over the last four years by SIL status and age group (non-SIL only).





Figure 4: Average payments per year – by age groups (non-SIL) (\$)4

Main support categories are defined as follows:

- Core SCC Core Social and Community Participation
- CB DA Capacity Building Daily Activities

The average number of participants in each time period is included in Table 1, along with the total and average amount of payments.

Figure 5: Average payments per year as at 30 June 2021 by support category and year - National




Figure 6: Average payments (SIL participants) per year as at 30 June 2021 by support category and year - National





Figure 7: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - National

Figure 8: Average payments per year as at 30 June 2021 by support category and year - New South Wales




Figure 9: Average payments (SIL participants) per year as at 30 June 2021 by support category and year - New South Wales




Figure 10: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - New South Wales




Figure 11: Average payments per year as at 30 June 2021 by support category and year - Victoria




Figure 12: Average payments (SIL participants) per year as at 30 June 2021 by support category and year - Victoria




Figure 13: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - Victoria




Figure 14: Average payments per year as at 30 June 2021 by support category and year - Queensland




Figure 15: Average payments (SIL participants) per year as at 30 June 2021 by support category and year - Queensland




Figure 16: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - Queensland




Figure 17: Average payments per year as at 30 June 2021 by support category and year - Western Australia




Figure 18: Average payments (SIL participants) per year as at 30 June 2021 by support category and year - Western Australia




Figure 19: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - Western Australia




Figure 20: Average payments per year as at 30 June 2021 by support category and year - South Australia




Figure 21: Average payments (SIL participants) per year as at 30 June 2021 by support category and year - South Australia




Figure 22: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - South Australia




Figure 23: Average payments per year as at 30 June 2021 by support category and year - Tasmania




Figure 24: Average payments (SIL participants) per year as at 30 June 2021 by support category and year - Tasmania




Figure 25: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - Tasmania




Figure 26: Average payments per year as at 30 June 2021 by support category and year - Australian Capital Territory




Figure 27: Average payments (SIL participants) per year as at 30 June 2021 by support category and year - Australian Capital Territory




Figure 28: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - Australian Capital Territory




Figure 29: Average payments per year as at 30 June 2021 by support category and year - Northern Territory




Figure 30: Average payments (SIL participants) per year as at 30 June 2021 by support category and year - Northern Territory





Figure 31: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - Northern Territory



Figure 32: Average payments (non-SIL participants) per year as at 30 June 2021 by support category and year - National




Most disability groups follow a similar upward pattern for average payments. The exception is participants with a sensory disability aged 15 to 24.

Figure 34: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Autism¹0





Figure 35: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Cerebral Palsy

Figure 36: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year – Developmental Delay¹¹





Figure 37: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Intellectual Disability

Figure 38: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Multiple Sclerosis¹²





Figure 39: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Psychosocial disability

Figure 40: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Sensory disability




Figure 41: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Spinal Cord Injury




Figure 42: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Stroke





Figure 43: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Other

Figure 44: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - New South Wales




Figure 45: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Victoria




Figure 46: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Queensland




Figure 47: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Western Australia




Figure 48: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - South Australia





Figure 49: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Tasmania¹⁶

Figure 50: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Australian Capital Territory





Figure 51: Average payments (non-SIL participants) per year as at 30 June 2021 by age group and year - Northern Territory 17
