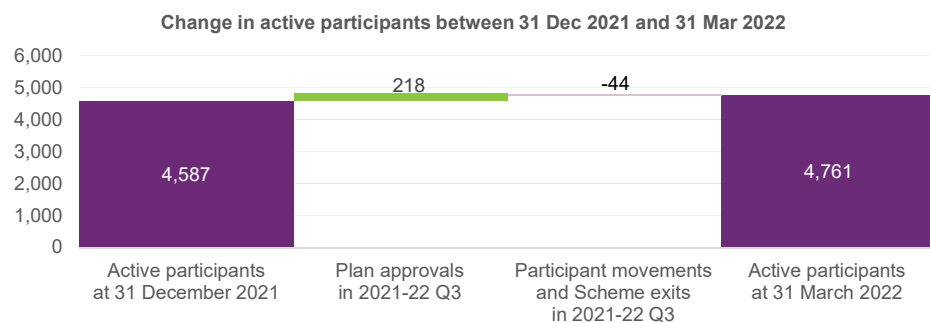

Performance summary:

- 5,016 participants (excluding children accessing early connections) have had an approved plan since July 2013. 4,761 of these continue to be active.
- 2,700 active participants are receiving supports for the first time.
- In the current quarter, 218 participants have entered the Scheme and there are 103 children accessing early connections at the end of March 2022.
- 582 plans have been reviewed this quarter.
- 251 access decisions have been made in the quarter, of which 202 met access and are still active.
- 110 (50.5%) of the new active participants this quarter identified as Indigenous, taking the total number of Indigenous participants in NT to 2,386 (50.1%).
- 16 (7.3%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) ³, taking the total number of CALD participants in NT to 312 (6.6%).

¹ PSG results in the previous quarter may be restated due to ongoing logic refinement and changes in data quality.

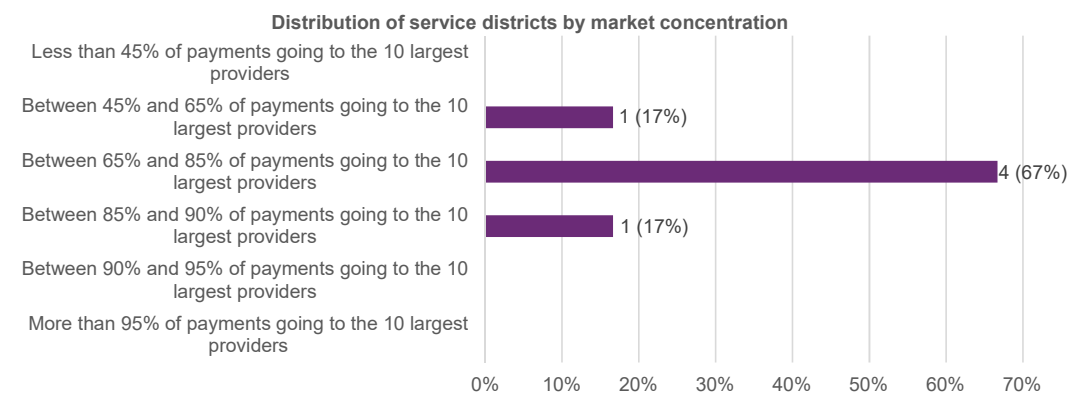
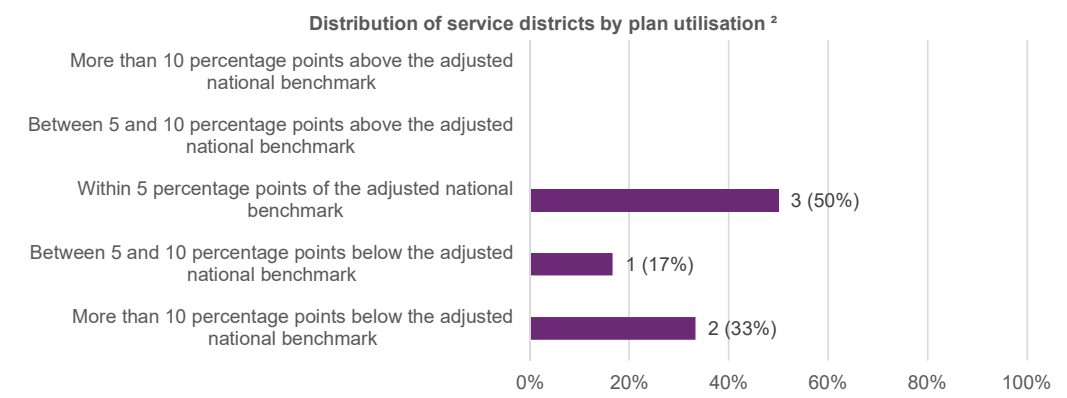
² ECEI was previously known as Early Childhood Early Intervention. It is now known as Early Childhood Approach (ECA)

³ The NDIA's new participant check-in process ensures that every scheduled review begins with a contact from the planner or partner to discuss review options well before any scheduled review date. Plans are extended automatically if they have not been reviewed before expiry so participants have continuity of support.

- Total annualised plan budgets at 31 March 2022 were \$531m and payments from 1 July 2021 were \$301m.
- The number of active providers at the end of March is 861, growing by 5% in the quarter.
- Utilisation was 74% from 1 July 2021 to 31 December 2021, with 33% (2 out of 6) of service districts in Northern Territory more than 10 percentage points below the adjusted national benchmark.
- In 17% (1 out of 6) of service districts, the top 10 providers provide more than 85% of payments.



Service districts more than 10% below plan utilisation benchmark:

- East Arnhem: 46% vs 69% benchmark
- Darwin Remote: 52% vs 65% benchmark

Service districts closest to market concentration benchmark:

- East Arnhem: 86% vs 85% benchmark

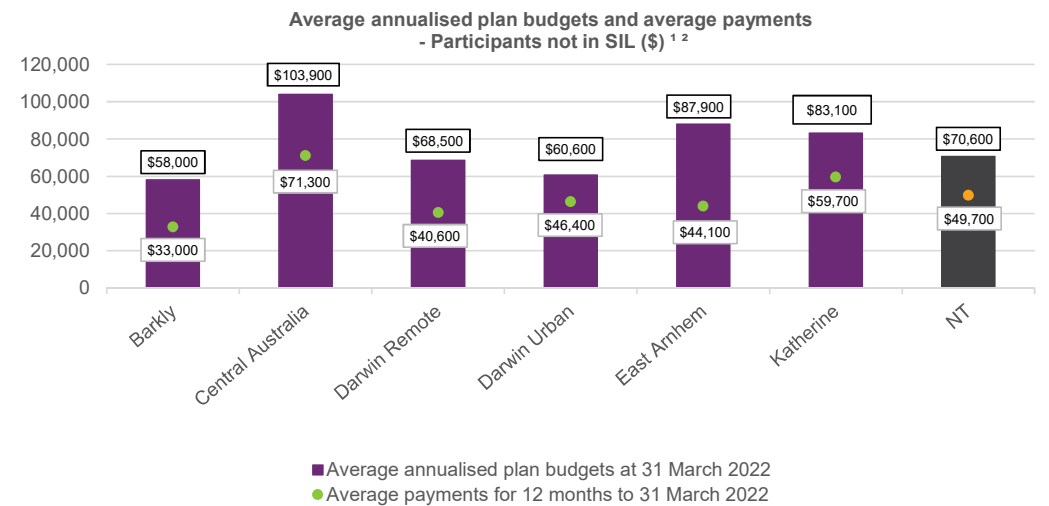
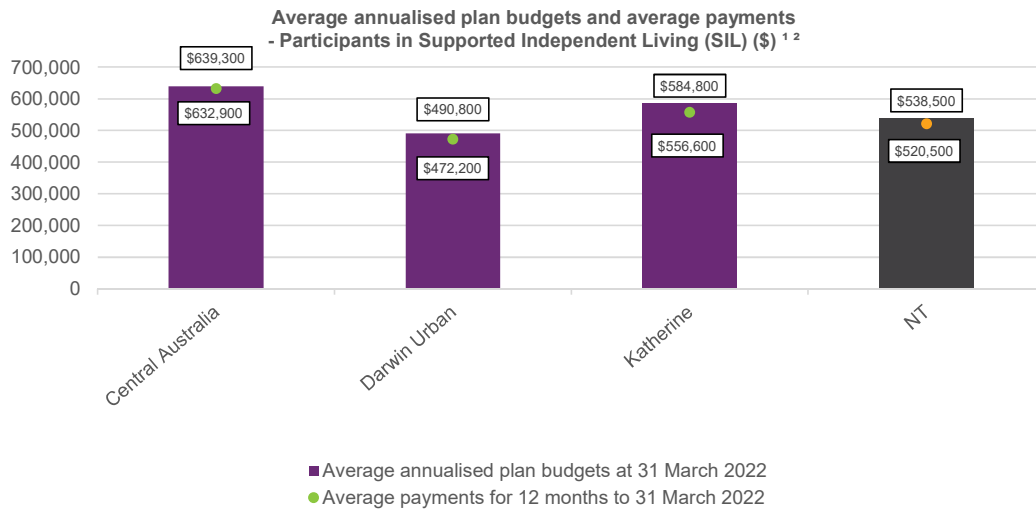
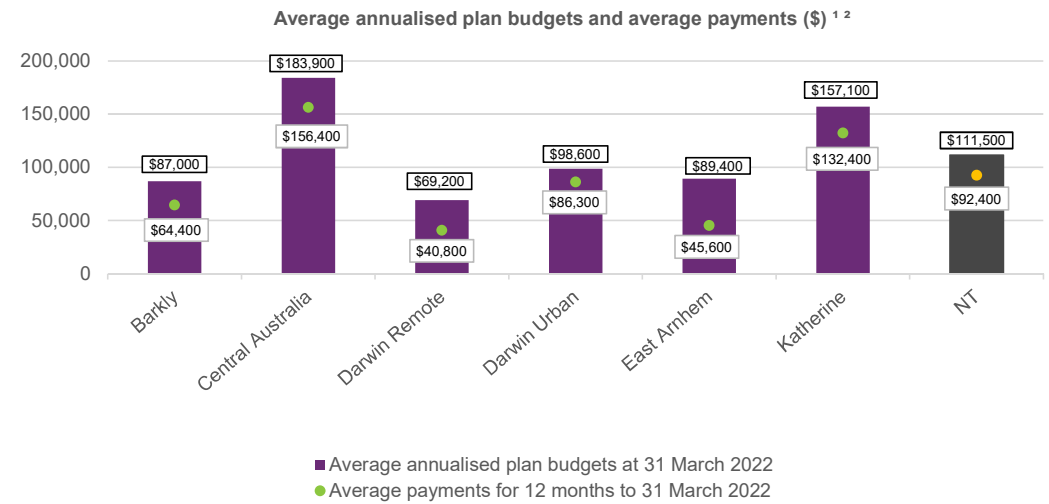
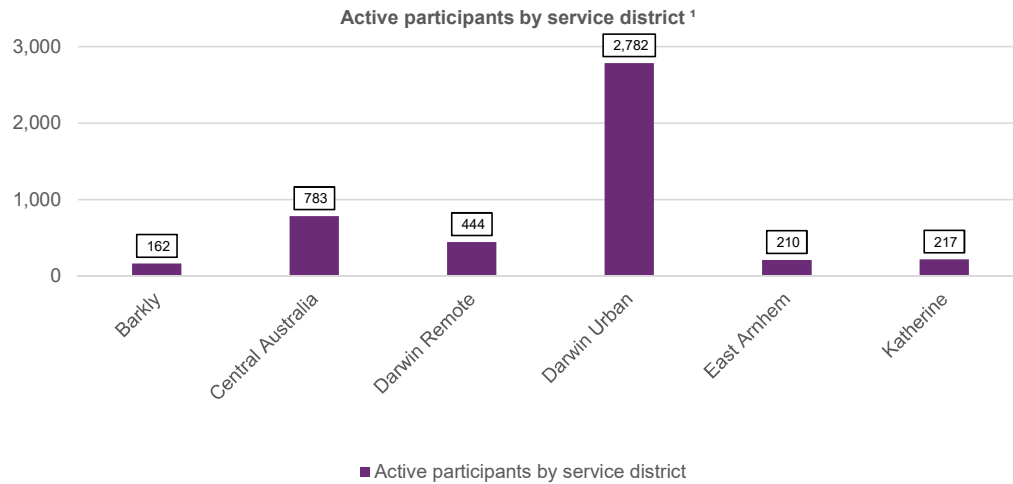
¹ Active providers refer to those who have received payment for supporting Agency-managed participants.

² The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in supported independent living in each service district and the length of time participants have been in the Scheme.

³ Total plan inflation consists of plan budget changes occurring at plan review, as well as changes occurring within a plan, between reviews. Previously the NDIA has not included the additional percentage changes in plan budgets that occur within a plan and before the scheduled review, when reporting this metric, and this has underestimated the extent to which plans have increased.

⁴ Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).

Summaries by service district



- Darwin Urban has the highest number (2,782) of active participants, while Barkly has the lowest (162).
- The average annualised plan budget at the end of March for active participants is \$111,500 (\$70,600 for participants not in SIL and \$538,500 for participants in SIL).
- The average payment for the 12 months ending 31 March 2022 is \$92,400 (\$49,700 for participants not in SIL and \$520,500 for participants in SIL).
- Central Australia has the highest average annualised plan budgets and payments across all participants.

¹ There are 163 active participants at 31 March 2022 residing in 'Other' service districts. 'Other' includes participants with service district information missing. The average annualised plan budgets and average payments for this group are not shown.
