

## Participant outcomes and satisfaction

#### Performance summary:

- 117,206 participants (excluding children accessing early connections) have had an approved plan since July 2013. 111,837 of these continue to be active.
- 68,380 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 4,683 participants have entered the Scheme and there are 3,814 children accessing early connections at the end of June 2022.
- 21,306 plans have been reviewed this quarter.
- 5,993 access decisions have been made in the quarter, of which 4,644 met access and are still active.
- 554 (11.8%) of the new active participants this quarter identified as Indigenous, taking the total number of Indigenous participants in QLD to 10,909 (9.8%).

• 245 (5.2%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD)<sup>3</sup>, taking the total number of CALD participants in QLD to 6,060 (5.4%).



• Total annualised plan budgets at 30 June 2022 were \$7,878m and payments from 1 July 2021 were \$5,961m.

- The number of active providers at the end of June is 7,108, growing by 3% in the quarter.
- Utilisation was 77% from 1 October 2021 to 31 March 2022, with no service district in Queensland more than 10 percentage points from the adjusted national benchmark.
- There were no service districts where the top 10 providers were providing more than 85% of payments.



<sup>1</sup> Active providers refer to those who have received payment for supporting Agency-managed participants.

<sup>2</sup> The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in supported independent living in each service district and the length of time participants have been in the Scheme.

<sup>3</sup> Total plan inflation consists of plan budget changes occurring at plan review, as well as changes occurring within a plan, between reviews. Previously the NDIA has not included the additional percentage changes in plan budgets that occur within a plan and before the scheduled review, when reporting this metric, and this has underestimated the extent to which plans have increased.

<sup>4</sup> Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).





Brisbane has the highest number (20,789) of active participants, while Bundaberg has the lowest (3,207).

- The average annualised plan budget at the end of June for active participants is \$70,400 (\$56,200 for participants not in SIL and \$363,900 for participants in SIL).
- The average payment for the 12 months ending 30 June 2022 is \$58,300 (\$42,800 for participants not in SIL and \$368,100 for participants in SIL).
- Cairns has the highest average annualised plan budgets and payments across all participants.
