Performance summary:

- 48,129 participants (excluding children accessing early connections) have had an approved plan since July 2013. 46,475 of these continue to be active.
- 27,609 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 1,626 participants have entered the Scheme and there are 827 children accessing early connections at the end of June 2022.
- 9,491 plans have been reviewed this quarter.
- 2,073 access decisions have been made in the quarter, of which 1,539 met access and are still active.
- 155 (9.5%) of the new active participants this quarter identified as Indigenous, taking the total number of Indigenous participants in WA to 3,611 (7.8%).
- 106 (6.5%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) ³, taking the total number of CALD participants in WA to 3,762 (8.1%).

² ECEI was previously known as Early Childhood Early Intervention. It is now known as Early Childhood Approach (ECA).


³ The NDIA's new participant check-in process ensures that every scheduled review begins with a contact from the planner or partner to discuss review options well before any scheduled review date. Plans are extended automatically if they have not been reviewed before expiry so participants have continuity of support.



- Total annualised plan budgets at 30 June 2022 were \$3,281m and payments from 1 July 2021 were \$2,292m.
- The number of active providers at the end of June is 2,555, growing by 5% in the quarter.
- Utilisation was 73% from 1 October 2021 to 31 March 2022, with 8% (1 out of 12) of service districts in Western Australia more than 10 percentage points below the adjusted national benchmark.
- In 25% (3 out of 12) of service districts, the top 10 providers provide more than 85% of payments.

Service districts more than 10% below plan utilisation benchmark:

- Kimberley-Pilbara: 56% vs 69% benchmark

Service districts closest to market concentration benchmark:

- Great Southern: 86% vs 85% benchmark


² The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in supported independent living in each service district and the length of time participants have been in the Scheme.

³ Total plan inflation consists of plan budget changes occurring at plan review, as well as changes occurring within a plan, between reviews. Previously the NDIA has not included the additional percentage changes in plan budgets that occur within a plan and before the scheduled review, when reporting this metric, and this has underestimated the extent to which plans have increased.


⁴ Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).


Active participants by service district ¹




Average annualised plan budgets and average payments (\$) ^{1 2}

- South Metro has the highest number (7,229) of active participants, while Goldfields-Esperance has the lowest (769).
- The average annualised plan budget at the end of June for active participants is \$70,600 (\$56,400 for participants not in SIL and \$342,000 for participants in SIL).
- The average payment for the 12 months ending 30 June 2022 is \$53,000 (\$39,600 for participants not in SIL and \$302,200 for participants in SIL).
- Central North Metro has the highest average annualised plan budgets and payments across all participants.

¹ There are 7 active participants at 30 June 2022 residing in 'Other' service districts. 'Other' includes participants with service district information missing. The average annualised plan budgets and average payments for this group are not shown.
