

Performance summary:

- 143,299 participants (excluding children accessing early connections) have had an approved plan since July 2013. 134,964 of these continue to be active.
- 91,335 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- In the current quarter, 5,444 participants have entered the Scheme and there are 5,876 children accessing early connections at the end of September 2023.
- 13,982 plans have had reassessments this guarter.
- 7,163 access decisions have been made in the quarter, of which 5,278 met access and are still active.
- 685 (12.6%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in Queensland to 13,977 (10.4%).
- 236 (4.3%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) 4, taking the total number of CALD participants in Queensland to 7,160 (5.3%).

¹ In the September 2023 quarter, the early childhood approach applies to children younger than nine, following implementation of the ECEI reset age range change project. This change will occur over the next two years and ensures children and their families are supported by an early childhood partner during and after their transition to primary school. This is a change from the June 2023 quarter, where the early childhood approach applied to children younger than seven.

² Trial participants (participants with initial plans approved prior to 1 July 2016) and those with initial plans approved after the end of 2022-23 Q3 have been excluded.

³ Plans less than 31 days in duration have been excluded from this tabulation, as these reassessments are more likely to represent corrections to the plan rather than a new plan reassessment to address a change in circumstance.

The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

¹ PSG results in the previous quarter may be restated due to ongoing logic refinement and changes in data quality.

- Total annualised plan budgets at 30 September 2023 were \$10.521m and payments from 1 July 2023 were \$2.129m.
- The number of active providers at the end of September is 8,281, growing by 3% in the guarter.
- Utilisation has been 78% from 1 January 2023 to 30 June 2023, with no service districts in Queensland more than 10 percentage points below the adjusted national benchmark.
- There were no service districts where the top 10 providers provide more than 70% of payments



- · Mackay: 39% vs 70% benchmark
- Rockhampton: 34% vs 70% benchmark


⁵ Total plan inflation consists of plan budget changes occurring at plan reassessment as well as changes occurring within a plan between reassessments.

The Annual Pricing Review saw price limit increases on 1 July where unspent portions of plan budgets were increased in line with indexation rates in July to maintain the purchasing power of remaining plans. There has been a one-off 2.5% increase in intraplan and total inflation during the month of July 2023.

Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).






Average annualised plan budgets and average payments

- Brisbane has the highest number (24,842) of active participants, while Bundaberg has the lowest (3,787).
- The average annualised plan budget at the end of September for active participants is \$78,000 (\$59,500 for participants not in SIL and \$436,400 for participants in SIL).
- The average payments for the 12 months ending 30 September 2023 are \$62,500 (\$44,700 for participants not in SIL and \$408,300 for participants in SIL).
- Cairns has the highest average annualised plan budgets and payments across all participants.

¹ There are 16 active participants at 30 September 2023 residing in 'Other' service districts. 'Other' includes participants with service district information missing. The average annualised plan budgets and average payments for this group are not shown.

² Figures are not shown if there is insufficient data in the service district.

³ Average annualised plan budgets are derived from total annualised plan budgets in the current plans of active participants at 30 September 2023. Average payments are calculated as the average of the annualised monthly payments in the same 12 month period, weighted by the participants that are active in each month.
