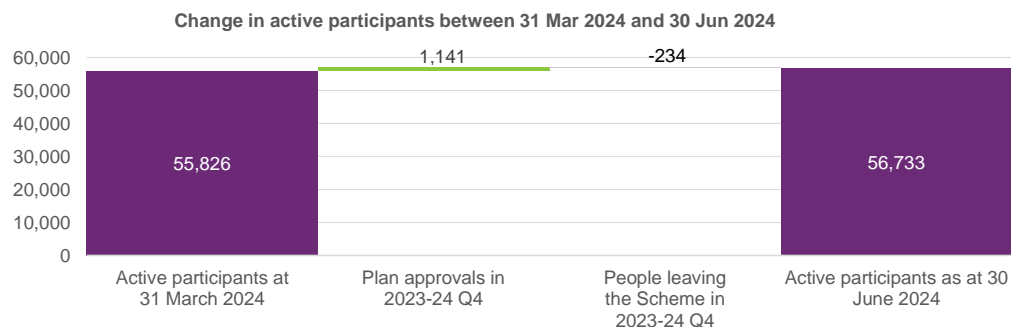

Performance summary:

- 61,544 participants (excluding children accessing early connections) have had an approved plan since July 2013. 56,733 of these continue to be active.
- 41,513 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- 1,141 participants have entered the Scheme in the June 2024 quarter and net participants leaving the Scheme are 234, reflecting active participant movements in and out of the Scheme and South Australia.
- 5,095 plans have had reassessments this quarter.
- 1,277 access decisions have been made in the quarter, of which 1,055 met access and are still active.
- 84 (7.4%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in South Australia to 3,762 (6.6%).
- 62 (5.4%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) <sup>4</sup>, taking the total number of CALD participants in South Australia to 3,955 (7.0%).

• The PSG metrics are based on the recommendations of the 2019 Tune Review. The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

<sup>1</sup> From the March 2024 quarter, performance is being measured using the available data on processes and dates. Milestones are being built into the new computer system to improve the capture of performance data. Where the performance remains unavailable for this quarter, "n/a" has been substituted.

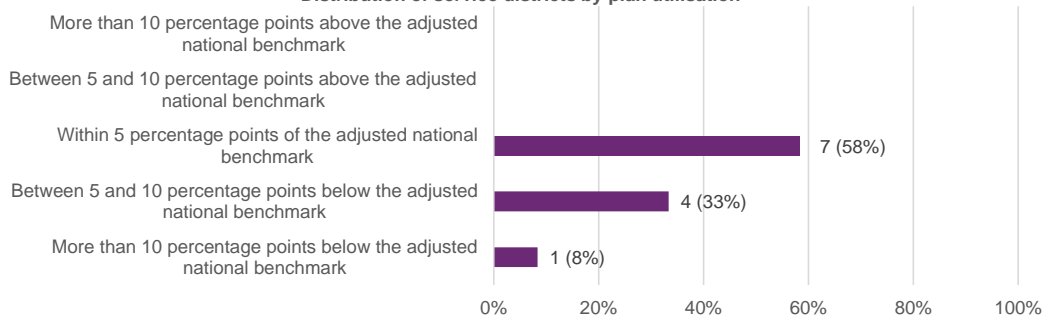

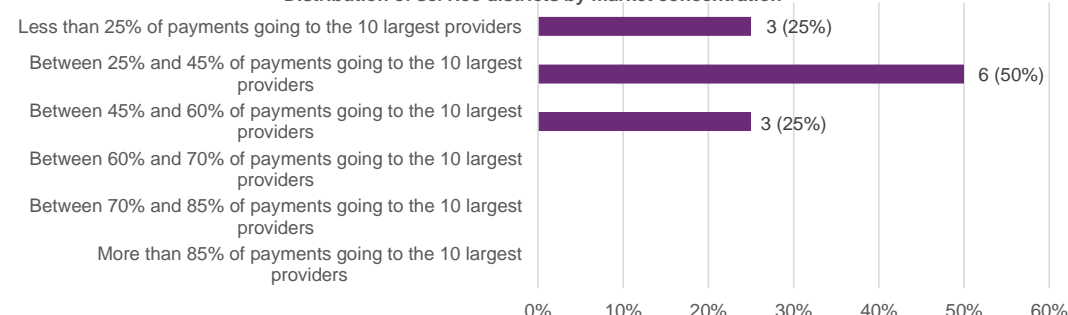

- Total annualised plan budgets at 30 June 2024 were \$4,480m and payments from 1 July 2023 were \$3,472m.
- Out of 18,846 active providers in the June 2024 quarter, 818 providers provided support to Agency-managed participants, 16,691 providers provided support to plan-managed participants and 5,023 providers provided support to self-managed participants.<sup>1</sup>
- Utilisation has been 77% from 1 October 2023 to 31 March 2024, with 8% (1 out of 12) of service districts in South Australia more than 10 percentage points below the adjusted national benchmark.
- There were no service districts where the top 10 providers provide more than 70% of payments.

### Service districts more than 10% below plan utilisation benchmark:

- Far North (SA): 62% vs 77% benchmark

### Service districts having between 45% and 70% of payments going to the 10 largest providers:

- Far North (SA): 56% vs 70% benchmark
- Limestone Coast: 55% vs 70% benchmark
- Murray and Mallee: 46% vs 70% benchmark

<sup>1</sup> From the March 2024 quarter, the active provider number includes both registered and unregistered providers. A participant may have a combination of plan management types over time.

<sup>2</sup> The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in Supported Independent Living (SIL) in each service district and the length of time participants have been in the Scheme.

<sup>3</sup> The payment enquiries come from the Provider Portal, Participant Portal and NDIS App.

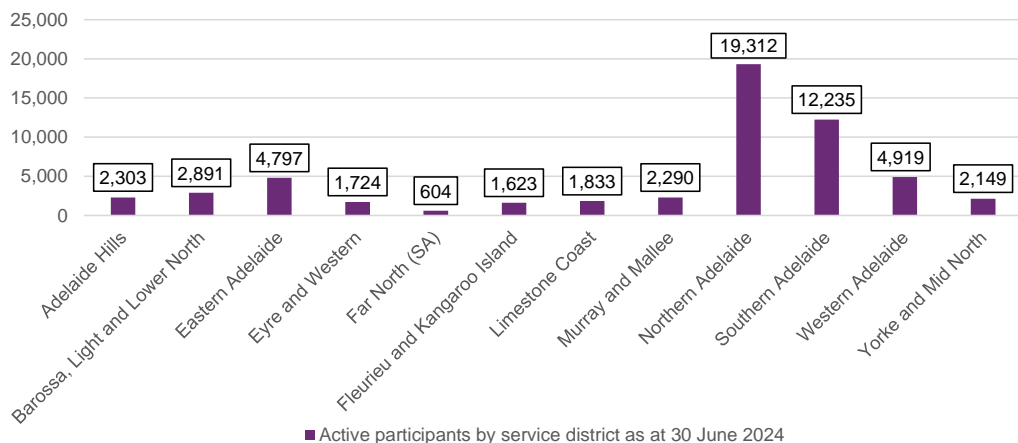
<sup>4</sup> Total annualised plan budgets refer to those in the current plans of active participants at the end of quarter.

<sup>5</sup> Total plan inflation consists of plan budget changes occurring at plan reassessment as well as changes occurring within a plan between reassessments.

<sup>6</sup> Socioeconomic status uses deciles from the ABS Index of Education and Occupation (IEO). A higher decile indicates that people residing in that area have a higher level of skills and qualifications on average. The socioeconomic equity metric is equal to the average annualised plan budget of participants residing in the top two IEO deciles divided by the average annualised plan budget of participants residing in the bottom two IEO deciles (participants not in SIL and aged 0 to 64).

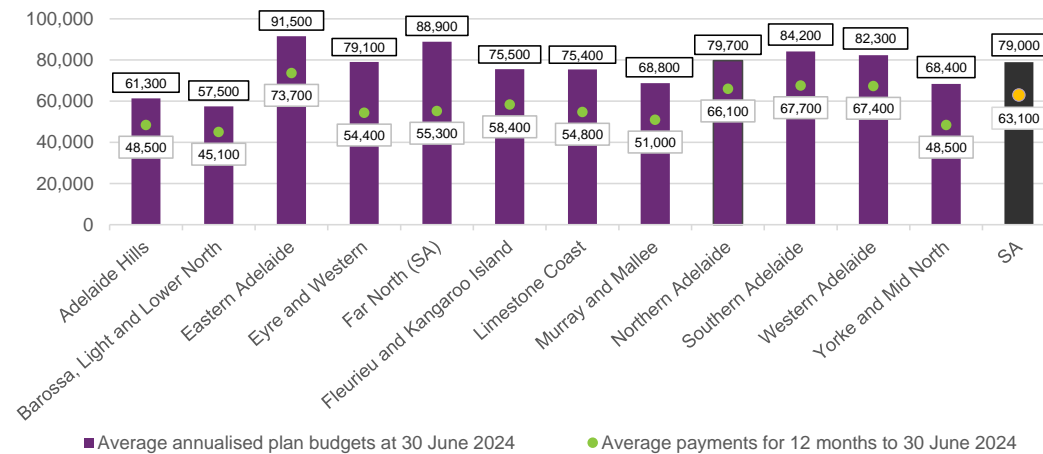

Active participants by service district <sup>1</sup>



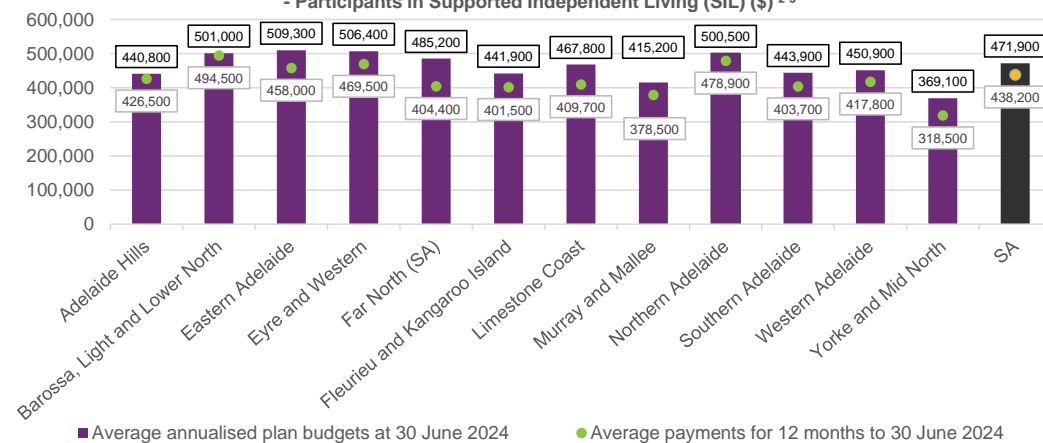
■ Active participants by service district as at 30 June 2024

Average annualised plan budgets and average payments (\$) <sup>2 3</sup>



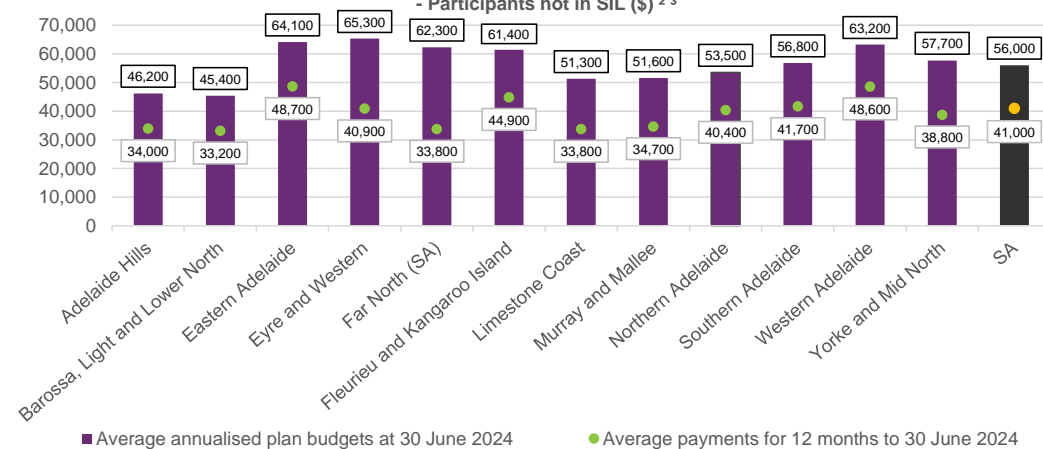
■ Average annualised plan budgets at 30 June 2024 ● Average payments for 12 months to 30 June 2024

- Northern Adelaide has the highest number (19,312) of active participants, while Far North (SA) has the lowest (604).
- The average annualised plan budget at the end of June for active participants is \$79,000 (\$56,000 for participants not in SIL and \$471,900 for participants in SIL).
- The average payments for the 12 months ending 30 June 2024 are \$63,100 (\$41,000 for participants not in SIL and \$438,200 for participants in SIL).
- Eastern Adelaide has the highest average annualised plan budgets and payments across all participants.

<sup>1</sup> There are 53 active participants as at 30 June 2024 residing in 'Other' service districts. 'Other' includes participants with service district information missing. The average annualised plan budgets and average payments for this group are not shown.

<sup>2</sup> Average annualised plan budgets are derived from total annualised plan budgets in the current plans of active participants as at 30 June 2024. Average payments are calculated as the average of the annualised monthly payments in the same 12 month period, weighted by the participants that are active in each month.
