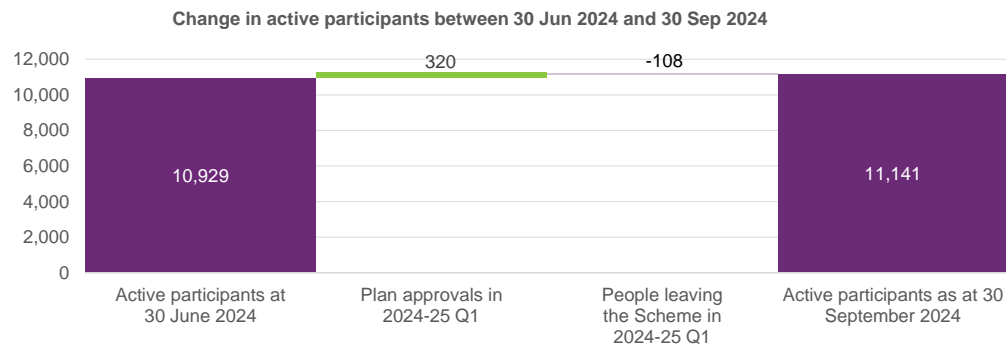

**Performance summary:**

- 12,977 participants (excluding children accessing early connections) have had an approved plan since July 2013. 11,141 of these continue to be active.
- 8,459 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- 320 participants have entered the Scheme in the September 2024 quarter and net participants leaving the Scheme are 108, reflecting active participant movements in and out of the Scheme and Australian Capital Territory.
- 854 plans have had reassessments this quarter.
- 353 access decisions have been made in the quarter, of which 274 met access and are still active.
- 24 (7.5%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in Australian Capital Territory to 521 (4.7%).
- 16 (5.0%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) <sup>5</sup>, taking the total number of CALD participants in Australian Capital Territory to 1,050 (9.4%).

<sup>2</sup> The early childhood approach indicators under the new system (PACE) continue to be refined. Some metrics are still unavailable and "n/a" has been substituted until these are resolved further.  
<sup>3</sup> Trial participants (participants with initial plans approved prior to 1 July 2016) and those with initial plans approved after the end of 2023-24 Q3 have been excluded.  
<sup>4</sup> Plans less than 31 days in duration have been excluded from this tabulation, as these reassessments are more likely to represent corrections to the plan rather than a new plan reassessment to address a change in circumstance.  
<sup>5</sup> The number of CALD participants excludes First Nations participants.  
<sup>6</sup> The Outcome results include participants who have been in the Scheme for at least two years. Trial participants (participants with initial plans approved prior to 1 July 2016) are excluded.

• The PSG metrics are based on the recommendations of the 2019 Tune Review. The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

<sup>1</sup> From the March 2024 quarter, performance is being measured using the available data on processes and dates. Milestones are being built into the new computer system to improve the capture of performance data. Where the performance remains unavailable for this quarter, "n/a" has been substituted.

- Total annualised plan budgets at 30 September 2024 were \$820m and payments from 1 July 2024 were \$168m.
- Out of 4,298 active providers in the September 2024 quarter, 347 providers provided support to Agency-managed participants, 3,313 providers provided support to plan-managed participants and 1,723 providers provided support to self-managed participants.<sup>1</sup>
- Utilisation has been 76% from 1 January 2024 to 30 June 2024, compared with an adjusted national benchmark of 79%.
- There were no providers receiving more than 70% of payments.
- The average annualised plan budget<sup>6</sup> at the end of September for active participants is \$73,600 (\$436,900 for participants in Supported Independent Living (SIL) and \$51,900 for participants not in SIL).
- The average payment<sup>7</sup> for the 12 month ending 30 September 2024 is \$58,200 (\$397,600 for participants in Supported Independent Living (SIL) and \$37,600 for participants not in SIL).

<sup>1</sup> From the March 2024 quarter, the active provider number includes both registered and unregistered providers. A participant may have a combination of plan management types over time.

<sup>2</sup> The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in Supported Independent Living (SIL) in each service district and the length of time participants have been in the Scheme.

<sup>3</sup> The payment enquiries come from the Provider Portal, Participant Portal and NDIS App.

<sup>4</sup> Total annualised plan budgets refer to those in the current plans of active participants at the end of quarter.

<sup>5</sup> Total plan inflation consists of plan budget changes occurring at plan reassessment as well as changes occurring within a plan between reassessments.

<sup>6</sup> Average annualised plan budgets are derived from total annualised plan budgets in the current plans of active participants at 30 September 2024.

<sup>7</sup> Average payments are calculated as the average of the annualised monthly payments in the same 12 month period, weighted by the participants that are active in each month.
