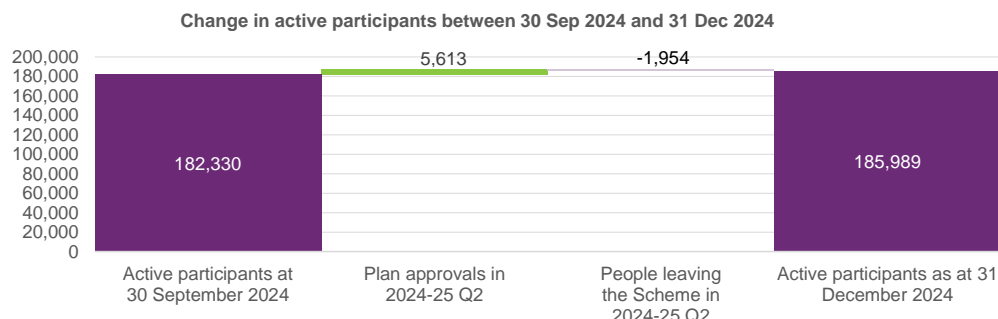

Performance summary:

- 203,926 participants (excluding children accessing early connections) have had an approved plan since July 2013. 185,989 of these continue to be active.
- 119,091 active participants have not previously received disability support via State and Commonwealth government programs in the past.
- 5,613 participants have entered the Scheme in the December 2024 quarter and net participants leaving the Scheme are 1,954, reflecting active participant movements in and out of the Scheme and Victoria.
- 15,434 plans have had reassessments this quarter.
- 7,023 access decisions have been made in the quarter, of which 5,627 met access and are still active.
- 247 (4.4%) of the new active participants this quarter identified as First Nations participants, taking the total number of First Nations participants in Victoria to 6,664 (3.6%).
- 504 (9.0%) of the new active participants this quarter are Culturally and Linguistically Diverse (CALD) ⁵, taking the total number of CALD participants in Victoria to 21,077 (11.3%).

¹ From the September 2024 quarter, the number of children accessing early connections is being reported as a 'throughout the quarter' figure rather than an 'end of quarter' figure to better reflect the number of children supported by the Early Childhood Approach.

² The early childhood approach indicators under the new system (PACE) continue to be refined. Some metrics are still unavailable and "n/a" has been substituted until these are resolved further.

³ Trial participants (participants with initial plans approved prior to 1 July 2016) and those with initial plans approved after the end of 2023-24 Q4 have been excluded.

⁴ From the December 2024 quarter, Plan Reassessments uses all reassessments including those from plans less than 31 days in duration (previously excluded). Logic for PACE plan reassessments is still being refined, hence the previous quarter's figures are subject to change.

⁵ The number of CALD participants excludes First Nations participants.

⁶ The Outcome results include participants who have been in the Scheme for at least two years. Trial participants (participants with initial plans approved prior to 1 July 2016) are excluded.

• The PSG metrics are based on the recommendations of the 2019 Tune Review. The NDIA commenced measuring performance against the PSG metrics prior to the legislation of the Participant Service Charter and Guarantee. On 30 March 2022, the NDIS Amendment (Participant Service Guarantee and Other Measures) Bill 2021 passed in both houses of Parliament, and received Royal Assent on 1 April 2022. It introduces changes that provide greater flexibility for participants and the NDIA to amend plans.

¹ From the March 2024 quarter, performance is being measured using the available data on processes and dates. Milestones are being built into the new computer system to improve the capture of performance data. Where the performance remains unavailable for this quarter, "n/a" has been substituted.

² ECA stands for early childhood approach.

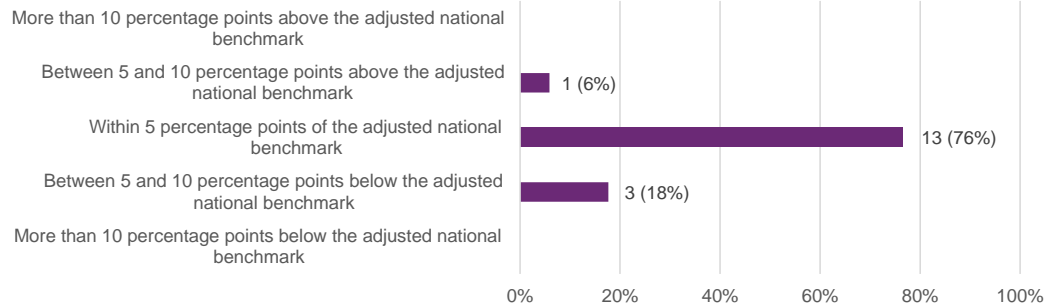
³ From the September 2024 quarter, the PSG timeframe (Service Agreement) to approve a plan for ECA participants after an access decision has been made was altered to 56 days (previously 90 days).

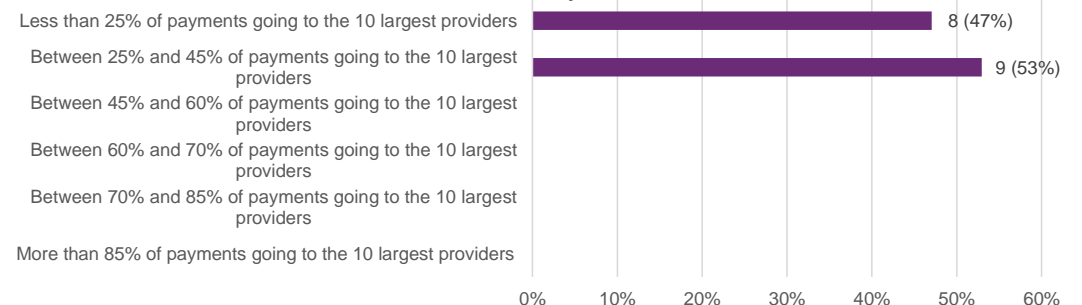

- Total annualised plan budgets at 31 December 2024 were \$14,208m and payments from 1 July 2024 were \$5,609m.
- Out of 80,348 active providers in the December 2024 quarter, 2,576 providers provided support to Agency-managed participants, 57,899 providers provided support to plan-managed participants and 41,400 providers provided support to self-managed participants.¹
- Utilisation has been 77% from 1 April 2024 to 30 September 2024, with no service districts in Victoria more than 10 percentage points below the adjusted national benchmark.
- There were no service districts where the top 10 providers provide more than 70% of payments.

Service districts between 5% and 10% below plan utilisation benchmark:

- Western District: 72% vs 79% benchmark
- Mallee: 71% vs 76% benchmark
- Loddon: 72% vs 77% benchmark

Service districts having between 25% and 45% of payments going to the 10 largest providers:

- Mallee: 42% vs 70% benchmark
- Western District: 39% vs 70% benchmark
- Ovens Murray: 32% vs 70% benchmark
- Central Highlands: 31% vs 70% benchmark
- Barwon: 30% vs 70% benchmark
- Inner East Melbourne: 29% vs 70% benchmark
- Outer Gippsland: 27% vs 70% benchmark
- Outer East Melbourne: 26% vs 70% benchmark
- Loddon: 25% vs 70% benchmark

¹ From the March 2024 quarter, the active provider number includes both registered and unregistered providers. A participant may have a combination of plan management types over time. From the December 2024 quarter, all providers were required to supply their ABN's to ensure inclusion in this metric (particularly for self-managed participants).

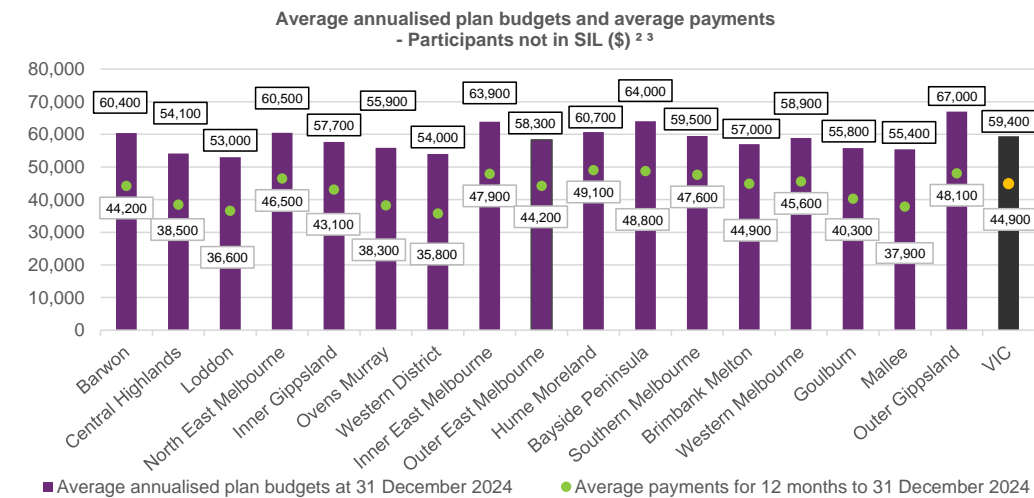
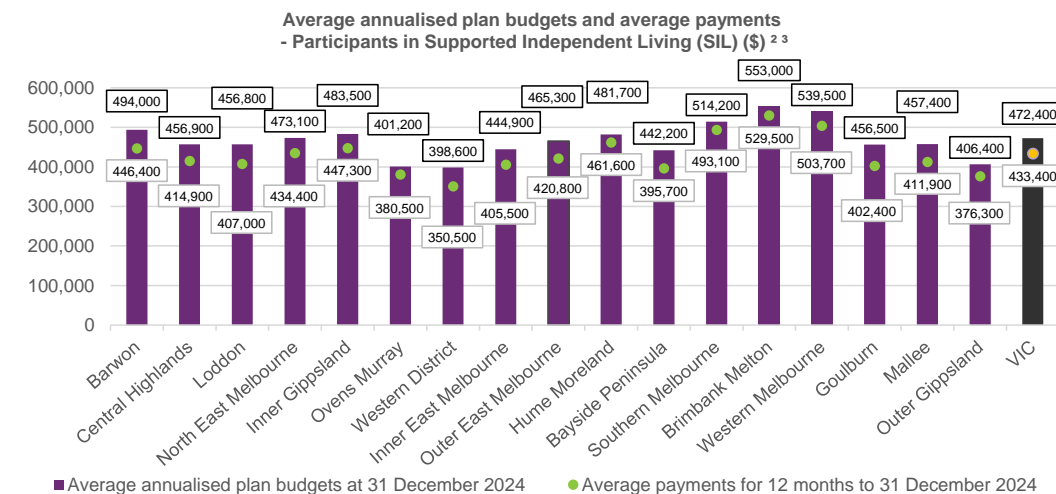
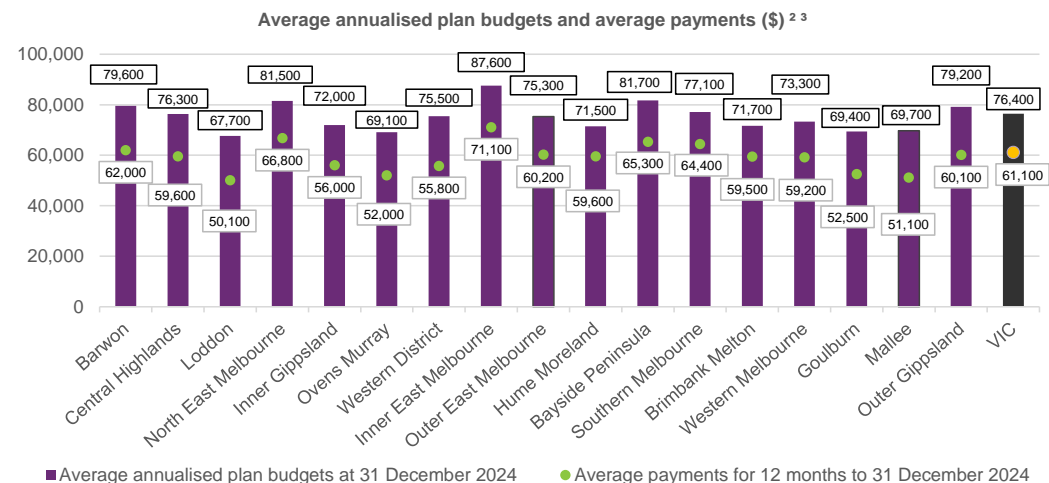
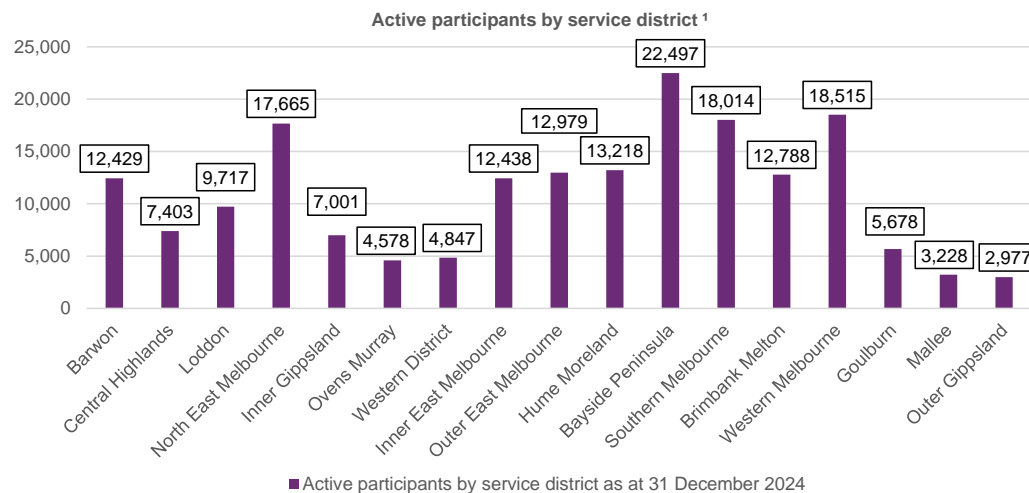
² The 'benchmark' in this analysis is the national average after adjusting for the proportion of participants in Supported Independent Living (SIL) in each service district and the length of time participants have been in the Scheme.

³ The payment enquiries come from the Provider Portal, Participant Portal and NDIS App. From Nov-24, the Agreed Timeframe measure for payments was updated to be 3-days in line with Performance Measure 2.2 within the Corporate Plan for 2024-25. This was previously 5 days.

⁴ Total annualised plan budgets refer to those in the current plans of active participants at the end of quarter.

⁵ Total plan inflation consists of plan budget changes occurring at plan reassessment as well as changes occurring within a plan between reassessments.

Summaries by Service Districts



- Bayside Peninsula has the highest number (22,497) of active participants, while Outer Gippsland has the lowest (2,977).
- The average annualised plan budget at the end of December for active participants is \$76,400 (\$59,400 for participants not in SIL and \$472,400 for participants in SIL).
- The average payments for the 12 months ending 31 December 2024 are \$61,100 (\$44,900 for participants not in SIL and \$433,400 for participants in SIL).
- Inner East Melbourne has the highest average annualised plan budgets and payments across all participants.

¹ There are 17 active participants as at 31 December 2024 residing in 'Other' service districts. 'Other' includes participants with service district information missing. The average annualised plan budgets and average payments for this group are not shown.
² Average annualised plan budgets are derived from total annualised plan budgets in the current plans of active participants as at 31 December 2024. Average payments are calculated as the average of the annualised monthly payments in the same 12 month period, weighted by the participants that are active in each month.
³ Figures are not shown if there is insufficient data in the service district.
