How we make pricing decisions

The NDIA is committed to ensuring the NDIS remains affordable and in place for future generations of Australians.

The NDIA recognises the importance of a diverse, sustainable and well-developed NDIS market, which promotes innovation, quality, continuous improvement and best practice and effectiveness to enable people with disability to exercise their right to choice and control in obtaining disability supports.

The NDIA sets pricing arrangements and price limits for many supports to ensure they:

- provide value for money for participants
- deliver fair and consistent participant outcomes
- support sustainable NDIS market growth
- promote the delivery of high quality innovative supports.

The current Pricing Arrangements and Price Limits are set in accordance with the NDIS pricing strategy which reflects the current situation of inefficient supply and growing demand.

It represents an approach to pricing aimed at:

- maintaining and increasing market supply
- helping markets grow to a more mature state in the future
- recognising the need for financial sustainability.

We regularly review and make changes to our pricing arrangements and price limits.

We use a variety of mechanisms to monitor market conditions, plan utilisation and market response to pricing arrangements.

The NDIA regularly releases [market monitoring reports](#) to assist stakeholders to understand market trends and [quarterly reports](#) on the performance of the NDIS.

Independent Review of NDIS funded music and art supports - Terms of Reference

We are commissioning an Independent Review of appropriate NDIS pricing for music and art supports, based on available evidence.

The review will assess:

- our existing review of evidence of effectiveness of art and music therapy for people with disability
- qualifications and registration of music and art practitioners
- pricing of art and music support.

The Independent Review will deliver its findings in March 2025.
