- support determinations

- where to access information, guidance and support.

## **What can you expect to hear?**

Presentations are developed using publicly available NDIA resources, including information from the NDIS website and operational guidelines.

The session brings together key information and explains it in an accessible and interactive format.

This session will provide a summary of the changes. Some changes to the scheme will take time and the detail of what these changes will look like have not been decided.

An estimated timeline of the proposed changes will be provided in the presentation.

## **Who is this webinar for?**

This session is designed for NDIS participants, carers, families, and kin, as well as supporting services such as advocacy organisations, peer support networks, and carers' groups.

We also encourage mainstream services that support people with disability including health, education, housing, and community services to attend.
