## Co-design Evaluation

In 2023, the NDIA commissioned an independent review of the NDIA's co-design work, by looking at past projects to understand what co-design had been done, what worked, what did not work, and any lessons for future processes.

The evaluation was led by Clear Horizon, with guidance from the Co-design Advisory Group. Findings were presented to the Co-design Advisory Group in late 2024, with a final report delivered by Clear Horizon in early 2025. This included recommendations around next steps and ideas to strengthen co-design and engagement going forward.
